OPT Workshop

What is OPT?

- ▶ Optional Practical Training is a temporary employment directly related to student's field of study.
- ▶ During OPT, a student remains in F-1 status.
- ▶ F1 students are eligible for 12 months OPT once for each higher educational level.
- ▶ LACC offers Post-Completion OPT. This means that you must be eligible to graduate at the end of the semester you wish to apply.

Eligibility to apply for OPT

- ▶ You must be in legal F1 status
- ▶ Be full-time student for at least one full academic year (2 semesters)
- ▶ You must be enrolled in the last semester of your program (to complete all the requirements for graduation)
- ▶ You must file for graduation in the A&R Office or show a proof of completion of the program (Educational Plan from academic counselor)

When does OPT employment begins?

- ▶ Employment begins after completion of academic program.
- ▶ Your intent should be to find full-time employment in your field of study.
- ▶ You do NOT need to have a job offer in place to apply for OPT.

If I am eligible, when can I apply ?

- ▶ You can apply as early as 90 days before your last semester end date
- ▶ Or during your grace period- within 60 days of your program end date.
- ▶ The last day of the semester
June 3, 2019

How do I apply?

- ▶ You will need to submit an I-765 application to USCIS with supporting documents.

www.uscis.gov

- ▶ You will need an I-20 with OPT recommendation from your DSO
- ▶ The filling fee is \$410.00 USD.
- ▶ The DSO will go over your OPT packet with you before you mail it to USCIS.

What happens if I fail a class and can't graduate this semester?

- ▶ **See your DSO as soon as possible.**
 - ▶ If you have already submitted an OPT application, we can cancel it and update your SEVIS information if you let us know early enough.
 - ▶ However, if you are approved for OPT and you do not pass your class, you may lose your OPT time.
 - ▶ **It is best to apply when you are sure you will pass your classes.**

How do I know if I am approved?

- ▶ You will receive letters from USCIS in the mail (I-797C notice)
- ▶ Or submit Form G-1145 (e-Notification) to receive email updates about progress.
- ▶ Once your OPT is approved, your EAD (Employment Authorization Document) card will arrive in the mail.
- ▶ You must submit a copy of your EAD card to the ISP office once you receive it.

What does an EAD card look like?

How do I pick a “start/end date?”

- ▶ When you apply, you must choose a “start date.”
- ▶ Your start date must be within 60 days after the last day of the semester.
- ▶ Your requested start date may differ from what USCIS actually approves.
- ▶ You can only start working on or after the start date that appears on your EAD card.

How do I get an SSN?

- ▶ You will apply to receive a Social Security number with your I-765 application.
- ▶ Your Social Security card will arrive by mail. <http://www.ssa.gov/>
- ▶ The adjudication of OPT with USCIS may take from 90 to 110 days.

How do I find a job?

- ▶ It is student's responsibility to find a job
- ▶ Check job websites and Brahma Jobs

How much time do I have to find a job?

- ▶ You are allowed a total of **90 days** of unemployment from the OPT start date on your EAD card.
- ▶ If you do not find a job within 90 days and you would like to maintain your OPT status, you should volunteer.
- ▶ Volunteering must be at least **20 hours** per week
- ▶ You should continue to search for paid employment even if you cannot find a job within 90 days of your OPT start date. Keep records!

Reporting your Employment

- ▶ **You must report your OPT employment to SEVP.**
- ▶ You will receive an email directly from SEVP to create a student portal account upon your OPT approval.
- ▶ It is student's responsibility to report the employment or changes in the employment to SEVP.
- ▶ Inform International Student Office if you don't receive an email to create an account.
- ▶ If you have difficulties reporting your employment directly to SEVP, you must report your employment to ISP.

What if I can't find a job?

- ▶ You can always volunteer – you will need to submit the address and information of your volunteer work to SEVP, make sure you keep records of your volunteer work!
- ▶ You will need to submit the info for your volunteer site.
- ▶ You can return to school.
- ▶ Start a new program at LACC.
- ▶ Transfer to a different college or university.

Health Insurance Information

- ▶ **You are NOT automatically insured through LACCD while on OPT.**
 - ▶ Re-enrolling with Relation Insurance will cost \$761 for a 6-month period of coverage.
 - ▶ Some employers may provide you with insurance coverage.
 - ▶ You may also choose an independent insurance provider such as Blue Cross, Study USA, etc. Be sure to read the policy clearly before you enroll.
 - ▶ **Health care in the US is extremely costly without proper health insurance.**

Keep the ISP updated!

- ▶ Per USCIS policies, you are required to inform the ISP of any periods of unemployment or changes in your employment history.
- ▶ You are also required to update your address and contact information if you move.
- ▶ You must inform the ISP of any changes within ten (10) days of the change.

Can I travel while on OPT?

- ▶ Yes, you can travel. Make sure you have the travel authorization signature from DSO on the 2nd page of your I-20.
- ▶ When you travel, you must have a support letter from your current employer and your EAD card to re-enter the USA.

Can I take a class while on OPT?

- ▶ Yes, you can take incidental classes while on OPT. See your DSO for approval.
- ▶ If you start working towards a higher degree level while on OPT, your I-20 may be terminated for violating USCIS policies.

What happens after I'm done with OPT?

- ▶ You have a 60-day grace period after you complete OPT. If you do not update your SEVIS record within that time, your I-20 will automatically be completed in SEVIS and you are expected to return to your home country ASAP.
- ▶ You can start a new program of study at LACC.
- ▶ You can transfer to another college or university.
- ▶ You can return to your home country.

Allowable Employment during Post-Completion OPT Employment must directly relate to the student's program of study.

- ▶ **Regular paid employment:**
 - ▶ May work for multiple employers.
- ▶ **Payment by multiple short-term employers:** (musicians and other performing artists)
 - ▶ May work for multiple short term employers (gigs).
 - ▶ Should maintain a list of all gigs, the dates and duration.
- ▶ **Work for hire:**
 - ▶ 1099 employment where an individual performs a service based on a contractual relationship.
 - ▶ Should keep evidence showing the duration of the contract periods and the name and address of the contracting company.

▶ **Self-employed business owner:**

- ▶ May start a business and be self-employed.
- ▶ Must have a proper business license.
- ▶ Be actively engaged in a business related to program of study.

▶ **Employment through an agency:**

- ▶ Should be able to provide evidence showing they worked an average of at least 20 hours per week while employed by the agency.

▶ **Volunteers or unpaid interns :**

- ▶ May work as volunteers or unpaid interns
- ▶ The work should be at least 20 hours per week
- ▶ Should be able to provide evidence acquired from the employer.

Which documents should I have to prove that I have been employed?

- ▶ Copies of job offer letters and agreements/contracts with all OPT employers including start and end dates.
- ▶ Copies of job descriptions including job title, duties, location, pay rate and proposed number of hours to be worked per week.
- ▶ If you worked for an agency, keep evidence of the projects you worked on.
- ▶ Keep copies of your pay vouchers or pay stubs for all periods of employment.
- ▶ Maintain copies of your bank statements that show direct deposits from your employer(s).
- ▶ Copies of your W-2 tax forms.

What if I want to transfer before my OPT period ends?

- ▶ You may transfer but your OPT period automatically expires once we release your I-20 to your new school.

OPT Package

Required documents to bring to International Student Office for OPT Recommendation: (see the package)

- ▶ Form I-765 Application for Employment Authorization
- ▶ Valid Passport
- ▶ I-94 Arrival and Departure Record www.cbp.gov
- ▶ 2 U.S. Passport Size Photos (2"X 2")
- ▶ Check or Money Order in the amount of \$410.00 made out to Department of Homeland Security
- ▶ Proof of completion of your Degree/Certification requirements (Ed. Plan or Graduation Petition)
- ▶ All I-20 Forms (current and previous schools)
- ▶ Any previous Employment Authorization Documents (EAD)
