Do not drop a course that will place you below 12 units without first obtaining DSO (Designated School Official) permission. RCL approval may be obtained by completing Sections 1, 2, and 3 of this form and then meeting with a DSO in the International Student Program (ISP) Office. Falling below 12 units during the Fall or Spring semester, without RCL approval will result in the termination of your F1 status.

- Students withdrawing from one or more courses must remain enrolled in at least 6 units (unless the RCL is for Medical reasons or for last

Student must provide medical documentation from a licensed:

- Medical Doctor
- Licensed Psychologist or Psychiatrist
- Doctor of Osteopathy

Documentation must be on:

- Letterhead
- Signed by M.D. with License #

and Include:

- Recommendation of units to be taken: Part-time or excused from all classes.
- Dates to be excused from classes (RCL request will be approved on a semester basis).
